How to present your application at Australia Post

- Ensure you have the appropriate identification documents for the highest possible category. Identification documents to be presented must contain matching personal information, be original and current (except for an expired Australian Passport which has not been cancelled and was current within the preceding two years).
 - If you have changed your name from that on an identification document, you will also need to provide a change of name document(s).
 - A translation will be required for all passports, driver licences and birth certificates if not in English. The translation is to be completed by a NAATI accredited translator (go to www.naati.com.au for details).

You should produce two Category 1 documents, if these have been issued to you. If you cannot satisfy Category 1 requirements, you must produce documents from the next highest category possible.~

- Identification documents presented must be original and current except for an expired Australian passport which has not been cancelled and was current within the preceding 2 years.
- Your photo will be taken by Australia Post and forwarded to Land Use Victoria.

- Copies of your identification documents, Registry instrument(s) and photo will be certified as true copies and forwarded to Land Use Victoria.#
- From 30 September 2019, the fee will be \$49.00 for the verification of identity service and is payable to Australia Post. Fees can be paid by cash, EFTPOS, Visa or MasterCard. Cheques are not accepted.
- Please bring your Land Use Victoria Registry Instrument(s) or other document(s) with you to present in-store. This will be witnessed by Australia Post when this form is lodged.**

* Must be issued by the Registry of Births, Deaths and Marriages. Documents issued by a celebrant are not acceptable.
You may be referred to Land Use Victoria regarding your application for verification of identity.
